Preliminary Reports (PR) of Kalasa Nala Diversion Scheme and Bhandura Nala Diversion Scheme were submitted to CWC by the Govt of Karnataka through E-PAMS on 03.08.2020. Comments of Inter-State matters and Hydrology aspects have already been forwarded to project authorities. Compliance from Project Authorities is awaited. However, Govt. of Goa has objected to CWC taking up the appraisal of the project, on the pretext that the award of MWDT is under challenge by all the parties, and till the time the issue is resolved, CWC should not appraise the project. The concerns of Govt. of Goa have been noted, and the same shall be put up to the Competent Authority once the preliminary appraisal of the projects reaches a formative stage.
