- 2. The sealed cover should be superscripted with words of "Supply, Installation, testing and Commissioning of two number of wall mounted Audio Visual Device with internet connectivity".
- 3. The detailed specification should be submitted along with the quotation.
- 4. The offer should be valid for a period of 60 days.
- 5. The rates quoted shall be FOR at Gandhinagar.
- 6. The offered rates should be inclusive of all taxes.
- 7. <u>Bid security amounting to Rs. 2,000/- (Rupees one thousand) only should be deposited along with the quotation</u> in the form of A/c payee DD / FDR / Bank guarantee of a scheduled bank in favour of the Ex. Engineer, Mahi Division, CWC, Gandhinagar (Gujarat).
- 8. For unsuccessful quotationers, bid security shall be refunded after finalization of tender. Bid security shall be forfeited if any quotationers with-draws their offer before finalization of the tender or fails to supply the items within the stipulated period from the date of order. In case of non submission of Bid security, the offer will be liable for rejection.
