CWC ADVISORY TO DAM AUTHORITIES :-

In accordance with established protocols and guidelines, you are hereby requested to regulate reservoir levels in compliance with Standard Operation Manuals / Rule Curves. This is imperative to mitigate the risk of downstream flooding and upstream submergence. Nevertheless, dam gate operations should proceed as per the established schedule, taking into account live storage capacity and making necessary adjustments to releases and filling to ensure optimal reservoir management.
