 - i. To develop irrigation assessment tools based on World Bank tool with few pilot study projects:
 - · Generic system for irrigation benchmarking
 - Scheme level performance assessment for selected irrigation systems (at higher resolution)
 - ii. Finalize irrigation benchmarking indicators based on irrigation assessment tools.
 - iii. Framework for operationalizing the irrigation benchmarking indicators based on irrigation assessment tools at NWIC Portal.
 - iv. Water Use Efficiency framework for Irrigation projects considering maximum utilization of remote sensing data.
- 3. Working Group may co-opt members and experts as per requirement and submit pilot study report by 30th April-2024.
- 4. ET based water accounting tool will be hosted/deployed at NWIC server. The data required for carrying out the pilot study will be provided by NWIC to CWC. Officers from CWC, NWIC, NIH and NRSC will be associated in this study with the support of World Bank Team.
